#### Secretary–Treasurer Report



- For the fiscal year ending April 30, 2023, we retained the firm of KPMG to conduct the audit.
- CAG received a Canadian Emergency Business Account (CEBA) loan for \$60,000 in 2021. This loan was unsecured and interest-free through December 31, 2023. A repayment of \$40,000 was made in early December 2023 and the remaining \$20,000 was forgiven by the CEBA program (via CIBC).
- No significant changes have been made to the CAG operating budget or the investment strategies for the CAG investment accounts (Legacy Initiative, Canadian Journal on Aging, and Menzies Bursary).

## Canadian Journal on Aging Report



- CJA impact factor is 2.14 for 2022.
- Manuscript management:
  - 59 Articles, 7 Policy and Practice/Research Notes, 5 Book Reviews, and 1 Editorial published in Issue 42(1-4).
  - From January 1, 2023 to November 30, 2023, 140 manuscripts were received compared to 142 during the same period in 2022.
  - From January 1, 2023 to November 30, 2023, the number of days to first decision (all manuscripts) was 59 days and the number of days to first decision (manuscripts with final decisions) was 56 days. This is lower than in 2022, where the number of days to first decision (all manuscripts) was 108 days.
  - The acceptance ratio for the prior 12 months is 30.1%.
